In the second level, the weights are applied to derive the weighted geometric aggregate (Cobb-Douglas) index. The weights represent the pattern of consumers' expenditure for Grenada, derived from the Household Income and Expenditure Survey conducted over the period October 2007 – February 2008.

The above table shows the computation of the Consumer Price Index for the month of November 2018 with changes for the previous month October 2018 and the corresponding month of last year November 2017. The overall index moved from 111.90 index points in October 2018 to 111.79 index points in November 2018 representing a decrease of 0.10%. An examination of the various groups revealed the following:

The groupings **"Alcoholic Beverages and Tobacco"**, "**Furnishing, Household Equipment and Routine Household Maintenance" "Transport"** and **"Miscellaneous Goods and Services**" recorded decline of 0.77%, 0.03%, 0.75% and 0.10% respectively. The following items contributed to these decreases: Beer 0.20%, Cigarette 2.40%, Non-durable Household Goods 0.22%, Motor Vehicle Fuel 4.23% and Products for Personal Care 0.25%.

Despite the overall decline, the following groupings **"Food and Non-Alcoholic Beverages"** and **"Health"** recorded increases of 0.09%, and 2.28% respectively, resulting from an increase in the price of: Bread and Cereal 0.06%, Pasta Products 0.68%, Mutton 2.65%, Poultry 0.32%, Delicatessen and Other Meat preparations 0.38%, Preserved Milk 0.22%, Eggs 0.84%, Preserved Fruits 0.55%, Fresh Vegetables 0.07%, Potatoes 2.07%, Jams and Honey 0.31%, Ice Cream 0.76%, Coffee, Tea and Cocoa Powder Products 0.25%, Mineral Water 0.12% and Pharmaceutical Products 4.97%. All the other groupings remained comparatively constant.

Relative to the corresponding month of last year, the index moved from 110.67 index points in November 2017 to 111.79 index points in November 2018 signifying an increase of 1.01%. The following groupings showed the following increases: **"Food and Non-Alcoholic Beverages"** 0.74%, **"Clothing and Footwear"** 0.12%, **"Housing, Water, Electricity, Gas & Other Fuels"** 1.47%, **"Furnishing, Household Equipment and Routine Household Maintenance"** 0.22%, **"Health"** 3.05%, **"Transport"** 1.67%, **"Education"** 5.99% and **"Miscellaneous Goods and Services"** 0.72%. The following items contributed to these increases: Pasta Products 1.71%, Beef 0.19%, Pork 1.00%, Delicatessen and Other Meat preparations 2.07%, Fresh Fish 1.65%, Preserved Fish 1.07%, Preserved Milk 4.46%, Cheese 1.27%, Eggs 1.42%, Butter 3.52%, Cooking Oil 1.83%, Fresh Fruits 1.80%, Potatoes 5.52%, Sugar 0.09%, Jams and Honey 2.79%, Ice Cream 3.20%, Children's Clothing 2.25%, the one hundred pound cylinder of Cooking Gas 5.58%, Bedroom Furniture 4.47%, Major Household Appliances 0.48%, Small Tools 0.60%, Non-durable Household Goods 0.47%, Pharmaceutical Products 6.66%, Motor Vehicle Fuel 2.23%, Passenger Transport by Air 26.27%, Pre-primary and Primary Education 2.19%, Tertiary Education 7.79%, Personal Care Products 0.35% and Insurance for Dwellings 9.92%.

On the other hand, the groupings "Alcoholic Beverages and Tobacco" and "Recreation and Culture" recorded decreases of 1.06% and 0.35% respectively, due to decline in the price of Cigarettes 4.12% and Personal Computers 1.55%.

Accordingly, the inflation rate for the period November 2018 is 1.01%. This can be compared to an increase of 0.76% for the same period in 2017.

Registered owners of such vehicles should present them to the Inspector of Motor Vehicles at any of the various Inspection Centres. For Public Services, Goods Vehicles & Trailers, inspection should be done early with a view to affecting any alterations that may be necessary to comply with the provisions of the Motor Vehicles and Road Traffic Act, and of the Regulations made there-under.

Vehicles must be presented in a thoroughly clean condition, and must have been recently overhauled. The body and wings, axle, chassis, frame, steering arms, springs, trackrods, brake connections, shackles, bolts, nuts, splitpins, engine, engine shield and case, clutch, gearbox, magneto or coil, air filter, carburetor and all working parts must be clean in order to have an examination in full. All splitpins, etc., must be clearly exposed, also chassis and engine numbers. Drivers' seats must be securely fastened so that the driver can have proper control over the vehicle. Spot lights, siren and musical horns and whistles are strictly prohibited. Each vehicle Trailer must have its tare and maximum gross weight painted in white figures not less than $2\frac{1}{2}$ inches in height upon a black background in a conspicuous place on the right or offside of the vehicles.

The licence plates and Identification marks on all vehicles must conform to provisions of S.R. & O. No. 41 Section 4 of the Motor Vehicles and Road Traffic (Amendment) Regulations 1991 and be in such a condition as to render each letter or figure readily distinguishable. The colour of plates must be YELLOW background, letters and numbers should be black.

The attention of owners of Motor Omnibuses and Goods Vehicles is specially directed to Regulation 23 (11) (a) regarding the position of front lamps. SPOT LIGHTS, FOG AND FALSE LAMPS WILL NOT BE ALLOWED except with a written approval of the Licensing Authority.

The attention of owners of Hiring cars and Motor Omnibuses is directed to Regulation 50 (2) of the Motor Vehicles and Road Traffic Regulations Chapter 201 of Volume IX of the Revised Laws of Grenada which required that printed copies of the tariffs and maximum fares be displayed on such vehicles. These are now available and may be purchased at the Treasury, St. George's, and at any District Revenue Office.

Vehicles which may have been found by the Inspector to have defects must not be used on the roads until they have been issued with certificates, certifying that the vehicles have been duly licenced.

N.B. Owners of Motor Vehicles are reminded of Section 11 (9) of the Road Traffic Act, which states that no Motor Vehicle shall be used for more than one (1) month after the change of ownership unless the new owner is registered as the owner thereof.

N.B.: THE MOTOR VEHICLE LICENCE SHALL BE AFFIXED TO THE LOWER END OF THE LEFT SIDE OF THE WINDSCREEN FOR BOTH LEFT & RIGHT HAND DRIVE VEHICLES.
